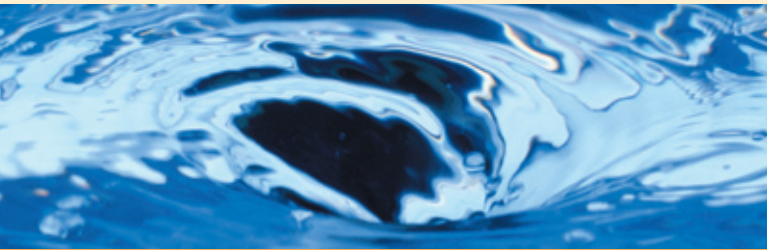


Did you know that new, high-efficiency toilets (HETs) and clothes washers use at least 40% less water than older models?

**New Construction: rebate \$80**

**Retrofit of 1.6 gallon toilet: rebate \$80**

**Retrofit of 1.7+ gallon toilet: rebate up to \$300\***

**CLOTHES WASHER: rebate \$200**
