Test Entry Requirements

1. Applications must be received, complete, with all required attachments and payments. Any application that is not complete by the 3:00 pm deadline may not be submitted for consideration for entry into the next regularly scheduled test. Incomplete applications will be returned.
2. The application deadline applies to new applicants AND requests to re-test an applicant.
3. Permits issued after passing December 5, 2013 test will be for the 2014 permit year.
