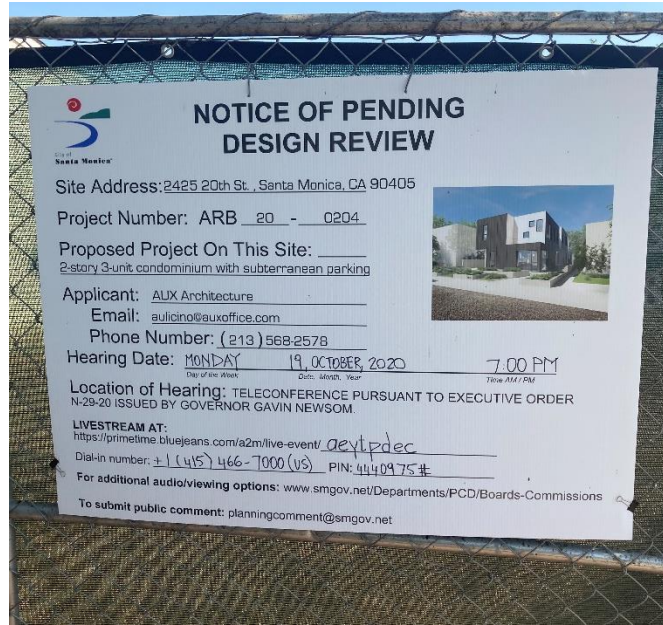

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SANTA MONICA AMENDING SANTA MONICA MUNICIPAL CODE CHAPTER 9.55: ARCHITECTURAL REVIEW TO INCREASE THE THRESHOLD FOR ADMINISTRATIVE APPROVAL FOR DESIGN REVIEW, ESTABLISH PROCEDURES FOR ADMINISTRATIVE APPROVAL, AND MAKE OTHER MINOR CHANGES, ADDITIONS AND CORRECTIONS

The following is a summary of Ordinance Number 2651 (CCS) prepared by the Office of the City Attorney:

On October 13, 2020, the City Council of the City of Santa Monica adopted Ordinance Number 2651 (CCS) (the "Ordinance"). The Ordinance amends Santa Monica Municipal Code Chapter 9.55, Architectural Review, to: increase the threshold for administrative approval for design review of projects that are limited in scope or routine in nature; establish procedures for administrative approvals conducted by City staff without review by the Architectural Review Board or any administrative appeal; and make other minor changes, additions and corrections.

The Ordinance will take effect thirty days after its adoption.
