This is my first foray into civic service; I have no previous city board or commission experience.

List community activities in which you are involved:

I have been a volunteer surf instructor for Boarding House Mentors since 2004; BHM is a non-profit that partners with organizations serving at-risk youth in the greater Los Angeles area. We not only teach young people - many of whom have never seen the ocean they live so near - water safety but also model personal respect and responsibility for ourselves, each other and our environment. Our motto is "Pass the Stoke" and we truly do! At the outset of the COVID crisis, from March-June of 2020, I was a volunteer driver for Masks for Docs, a non-profit that, in the earliest days of the pandemic, collected donated PPE and distributed it to area caregivers at nursing homes & hospitals that had shortages. I worked as a contact tracer for the state of Maryland - maybe not MY community but a community in need - during the most crushing days of their COVID outbreak from Thanksgiving 2020 through January 2021.

Personal qualities identified in the criteria include leadership, creativity, and innovation as well as the ability to work effectively in a group setting and an ability to balance competing needs. Provide examples of how you have demonstrated those qualities:

I believe leadership is a mantle one may wear regardless of the number, if any, they may lead or claim as followers. It's an ethos that embraces and evokes competence, capability, creativity, curiosity and critical thinking, to name just a few attributes. For the past 5 years, prior to the pandemic, I worked on a nationwide, federally funded research study - conducted in person - on substance abuse and mental heath. A more personal or provocative subject is hard to imagine, yet I consistently gained cooperation and participation in what was a wholly voluntary study from people of every age, (including parents of minors 12+), race, religion, social & economic background. I do not credit myself with what I nevertheless seem to possess, which is an authenticity and honesty that engenders trust. I also proved myself to be a reliable, discreet and understanding professional, as reflected in the random quality control follow-up calls made to my respondents.

I've gained both knowledge and experience in social policy & issues through my work in behavioral research. In addition to my work on the NSDUH (National Survery on Drug Use and Health) mentioned above, I also worked on the 2019 NSECE (National Survey on Early Care and Education) and it's COVID-19 related 2020 follow-up. All these studies were designed to generate data that would inform policy on the local, state and national level. Prior to my Field Interviewer work, I worked as a transactional paralegal in the entertainment and tech industries, acquiring vast and varied experiences with a broad range of legal issues.
