

RESOLUTION NO. 5333 (CCS)

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANTA MONICA RECITING THE FACT OF THE ELECTION HELD IN SAID CITY OF SANTA MONICA ON THE 26TH DAY OF JUNE, 1979, AND ADOPTING THE STATEMENT OF RESULTS OF VOTES CAST.

WHEREAS, a Special Municipal Election was held and conducted in the City of Santa Monica in Los Angeles County, State of California, on Tuesday, the 26th day of June, 1979, as required by law;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SANTA MONICA DOES RESOLVE AS FOLLOWS:

SECTION 1. That there were 54 consolidated voting precincts and that the total number of ballots cast was 16,200.

STATEMENT OF THE CITY CLERK

I, Joyce Snider, City Clerk of the City of Santa Monica hereby certify the following:

That at the Special Municipal Election held June 26, 1979, as provided for by the Charter of the City of Santa Monica and the Elections Code

of the State of California, there were 54 consolidated voting precincts established within the boundaries of the City of Santa Monica; that the absent voter ballots were canvassed by a Board appointed by the City Clerk as provided for in the State of California Elections Code and that the official canvass was commenced by the City Clerk on June 27, 1979, and completed on July 2, 1979; that the voting was done by electric vote recording equipment (IBM) in accordance with the provisions of the State of California Elections Code; that there were a total of 16,200 ballots cast; that the following were candidates for the various offices:
